MOTION FOR VOLUNTARY DISMISSAL

Pursuant to Rule 42(b) of the Federal Rules of Appellate Procedure, Appellants MetroPCS Communications, Inc., MetroPCS 700 MHz, LLC, MetroPCS AWS, LLC, MetroPCS California, LLC, MetroPCS Florida, LLC, MetroPCS Georgia, LLC, MetroPCS Massachusetts, LLC, MetroPCS Michigan, Inc., MetroPCS Networks California, LLC, MetroPCS Networks Florida, LLC, and MetroPCS Texas, LLC (collectively, "MetroPCS"), respectfully move for voluntary dismissal of the above-captioned action, with each party bearing its own costs.
